3. President's Report on the Overview of the Association 2014-2015

The President gave an overview of the activities of the past year. A new corporate account has been opened for the Association. During the past year networking and co-operation within members and other stakeholders was strengthened. The vision for EAFP is to understand the needs of pharmacy educators and the profession, to act as a forum for sharing of experiences so

as to spearhead developments in pharmacy education methods, research in pharmacy and to support professional developments.

A Council of Deans is being proposed and the first preparatory meeting took place in Athens during this Annual Conference. An EAFP Past Presidents and General Secretaries Council has been established as an advisory group within EAFP. The President had several meetings with FIP, participated in the FIP-Academic Institutional Membership Advisory Board meetings and is representing EAFP at the FIP Sub-Committee for the Global Conference on Pharmacy Education in 2016. Regular meetings were held with the European Association of Hospital Pharmacists, the Pharmaceutical Group of the European Union (PGEU), the European Industrial Pharmacists Group and the European Pharmaceutical Students Association (EPSA). With PGEU and EPSA, EAFP is discussing proposals for consideration in the updates of the EU-Directive on Pharmacy Education. With EAHP, EAFP is participating as a partner in a COST project on Medicines Shortages. EAFP is participating as a partner at the forthcoming South East Europe (SEE) Quality in Pharmacy Summit. The abstracts from the EAFP Annual Pharmacy Conference will be published in the FIP Pharmacy Education on-line journal starting from the abstracts submitted for the 2015 conference.

By unanimous agreement of the Executive Committee, the President proposed a motion for EAFP to apply for FIP Observer Organisation status. This will support the advocacy position of EAFP as the European leader in pharmacy education in international fora. The proposal was accepted and the application will be submitted to FIP for consideration at the FIP Council Meeting in September 2015.
