## **Abstract Submission Guidelines**

All abstracts must be prepared according to the instructions below and the abstract template attached.

Abstract must be written in English and should include the following structured information:

- Introduction
- Materials and methods
- Results
- Conclusions

Abstracts should not exceed 300 words.

Abstracts should not include any tables or figures.

Abstracts which meet the Pharmacy Education Journal review criteria will be published in the journal.

## **Abstract template**

## THE COMPLETE TITLE SHOULD BE CAPITALISED, on the Left of the Page in Times New Roman font, 14 Point

**Authors:** (Times New Roman, 10 point, left) Initials and Surnames for every author must be provided. Do not include degrees or titles. The name of the presenting author should be underlined. Include **ORCID iD** for each author.

**Affiliations:** The affiliations should be typed under the list of authors' names. Each author should be listed by institution, city, state/province and country. In abstracts where the authors have different affiliations, please indicate for each author the number of the corresponding affiliation – use superscript.

**Text:** Abstract text must be in Calibri font, 12-point, single spacing and justified text. **Abstract text should not exceed 300 words. No tables or figures should be included.** Abbreviations should be kept to a minimum. Place abbreviations in parentheses after the full term for the first time it appears. Linguistic accuracy is the responsibility of the authors. Drug products mentioned in the abstract should be identified by their non-proprietary names only. Do not capitalise non-proprietary names.

Distribute the text in the following sections:

Introduction
Materials and Methods
Results
Conclusions

Literature References: *Optional* (list one or two *maximum*, according to Vancouver style). **Must be included in 300-word limit.**
